This year's Journal offers some real problems. This was the year of the unification of the Methodist Episcopal Church, South (the "Southern" church, hereafter MES), the Methodist Episcopal Church (the "Northern" church, hereafter ME), and the Methodist Protestant Church into The Methodist Church (you seldom see "The" capitalized, but the official name did capitalize it). The existing Memphis Conference was of the MES. The list of changes is confusing and in some instances incomplete. What follows is a by-district account of churches received and merged as listed in the charge line changes.

#### **Jackson District**

MERGER: New Castle (MES) and Hickory Valley (MES), both Hardeman County, with the merged name being Hickory Valley.

MERGER: Sardis (ME) and Sardis (MES), Henderson County

RECEIVED: Union Hill (ME, Henderson County) to Sardis Circuit

RECEIVED: Liberty (Weakley County; this church is not geographically placed, and the Memphis Conference then had several Liberty churches, but this one was located to the southeast of Dresden ) from the Methodist Protestant Church and put on the Huntingdon Circuit

RECEIVED: Cedar Grove (ME, Benton) and Pleasant Hill (ME, Benton) placed on north Camden Circuit

MERGER: Lexington MES and Lexington ME

MERGER: Parsons MES and Parsons ME

MERGED: Bruceton MES and Bruceton ME

RECEIVED: Liberty ME and add to Holladay Circuit. Two of the several Liberty Churches of the Memphis Conference were in Benton County. One (not this one) was north of Camden; this one was somewhere is South Benton County).

RECEIVED: Cedar Grove (ME, Henderson County) and Union Cross (ME, Henderson County) put on North Lexington Circuit

RECEIVED: Poplar Grove (ME, Henderson County) put on Lexington Circuit

#### Paducah District

NAME CHANGE: Guthrie (Paducah) to Marlie Wallace Memorial

DISCONTINUED: Hendron (noted as a schoolhouse appointment; no property)

# NOTE ON INCOMPLETE INFORMATION

There is no mention of Trinity Church, Paducah, being received from the ME church, which it was.

There is no mention of the Birmingham Circuit (Paducah District) being received from the ME church, which it was. In 1940 the name was changed to the Benton Circuit. In the first Journal to list individual names of churches on circuits after 1939 (1946) the churches of the Benton Circuit were Briensburg, Church Grove, Liberty, Maple Springs, and Mt. Carmel. I (Harrell Phillips) am not certain on Liberty, but the other churches listed in 1946 were received from the ME church.

Was Calvary (Mayfield) received from the ME church? Its proximity (then) to First Church makes me think that it was.

Henderson Circuit is absorbed in the above changes.

Take Lebanon, Shady Grove, Union Grove, and Corinth from the Sardis Circuit, of the former Methodist Episcopal Church, and add to

Take Pebble Hill from Pebble Hill Circuit, of the former Methodist Protestant Church, and add to the Adamsville Circuit, of the former Methodist Episcopal Church, thus forming a new circuit to be known as North Adamsville Circuit.

Take Liberty from Gleason Circuit, of the former Methodist Protestant Church, and add to Huntingdon Circuit.

Take Shiloh, Flatwoods, and Mount Carmel from Camden Circuit; take Friendship from Bruceton Station; take Cedar Grove and Pleasant Hill from Big Sandy Circuit, of the former Methodist Episcopal Church, and form a new circuit to be known as North Camden Circuit.

Combine the Lexington Station Churches of the former Methodist Episcopal Church, South, and the former Methodist Episcopal Church,

to form the Lexington Station of The Methodist Church.

Combine the Parsons Church of the former Methodist Episcopal Church, South, and of the former Methodist Episcopal Church, forming the Parsons Church of The Methodist Church.

Combine the Bruceton Church of the former Methodist Episcopal Church, South, and of the former Methodist Episcopal Church, to form the Bruceton Church of The Methodist Church.

Take Liberty from Parsons Circuit, of the former Methodist Episcopal Church, and add to Holladay Circuit.

Take Sharon and Rock Springs from the Lexington Circuit; Cedar Grove and Union Cross from Lexington Circuit, of the former Methodist Episcopal Church. Form a new circuit to be known as North Lexington Take Poplar Grove from Lexington Circuit, of the former Methodist Episcopal Church, and add to Lexington Circuit. Memphis District: No changes. Paducah District: Take Corinth from Lowes Circuit; take Lovelave-ville from Bardwell, Wickliffe, and Lovelaceville and form a new charge Take Massac from Lowes Circuit; Palma from Calvert City Circuit; Oak Grove and Littleville from Hendron, Oak Grove, and Littleville; the four churches to form a new circuit to be known as Paducah Circuit. Take Faxon, Crooked Creek, Luterton, Harmon's Creek, Sulphur Creek from Faxon Circuit; Antioch from Mansfield Circuit; New Hope from Big Sandy Circuit; and Mount Vincent from Big Sandy Circuit, of the former Methodist Episcopal Church; form a new charge to be McLemoresville and Liberty All is a new charge from the former Methodist Episcopal Church. Union City District: Rice City is placed back on the Fulton Circuit.

Resolved, That the following acts be taken and done by the said Memphis Annual Conference of the Methodist Episcopal Church, South, in accordance with and fulfillment of the provisions of the Plan of Union and the directions of said Uniting Conference.

WHEREAS, There was heretofore incorporated under the laws of the State of Tennessee a corporation under the title of "Memphis Annual Conference of the Methodist Episcopal Church, South, Incorporated," to which corporation have been entrusted the title to all property and trusts acquired and held for the benefit of the Memphis Annual Conference of the Methodist Episcopal Church, South; now, therefore, be it

Resolved, That said corporation, to wit, Memphis Annual Conference of the Methodist Episcopal Church, South, Incorporated, be and the same is hereby authorized, empowered and directed to hold all property, real and personal, and all trusts of whatever kind heretofore acquired as well as all property rights and trusts that may arise in the future, upon the same basis, and for the same uses and trusts in behalf of the sucthe same pasis, and for the same uses and trusts in benaif of the successor Conference, to wit: Memphis Annual Conference of The Methodist Church, as said property and trusts heretofore have been and are now held for the Memphis Annual Conference of the Methodist

Resolved, That the Memphis Annual Conference of the Methodist Episcopal Church, South, does hereby transfer, assign and convey unto successor, all of its property, real, personal and mixed, including all interests in trusts, powers, franchises, rights, privileges, titles, accounts receivable, subscriptions, and other properties which it now possesses and holds, or to which it may hereafter be or become entitled, said transfer, assignment, grant or conveyance to be effective immediately upon the organization of the successor Memphis Annual Conference of The Meth-

Resolved, further, That it be hereby declared that the said Memphis Annual Conference of The Methodist Church when organized shall be in every respect, whether enumerated or not, the ecclesiastical and lawful successor of the Memphis Annual Conference of the Methodist Episcopal

Resolved, That, in accordance with the Plan of Union and the legislation enacted in pursuance of the same, each and every one of the Corporations, Boards and Societies now subordinated or owing allegiance in any way to the Memphis Annual Conference of the Methodist Episcopal Church, South, shall continue to hold the same allegiance, duty and loyalty to the Memphis Annual Conference of The Methodist Church, and royalty to the memphis Annual Conference of the mediate Church, South, and all the authority and power to enforce such allegiance and duty are hereby
