We further recommend that the property, valued at \$1,000 be deeded to the Salvation Army as an outpost for its work with the understanding that a reversionary clause in the deed shall make it clear that said property shall revert to the Methodist Church if it should ever cease to be used by the Salvation Army for its normal work.

We further recommend that the Conference Trustees shall negotiate for any and all transactions in disposing of said property." Signed, W. B.

Vernon Church on the Dresden Circuit is now without membership, I, therefore, move that the property be sold, the proceeds to be used to build a parsonage for the Lynville-Storey's Chapel Charge. The quarterly conference of the Dresden Circuit asks that this disposition be made of the property."—Signed, W. E. Mischke, District Superintendent.

CROOKED CREEK CHURCH—The following resolution was adopted.

"WHEREAS, the Crooked Creek Church membership has voted to unite with the Big Sandy and Faxon Churches on the Big Sandy Circuit, and the Quarterly Conference has taken appropriate action, I, therefore, move that the Church be discontinued." Signed, W. E. Mischke, District Superintendent.

UNION HALL CHURCH—The following resolution was adopted.

"WHEREAS, the Union Hall Church membership has voted to unite with the Cottage Grove Church on the Cottage Grove Circuit, and the Quarterly Conferences have taken appropriate action, I, therefore, move that the property be sold and the proceeds be used to apply on the remodeling or rebuilding of the Cottage Grove Church." Mt. Zion Church—The following resolution was adopted.

"WHEREAS, the membership of the Mt. Zion Methodist Church on the Sardis-Milledgeville Charge has become wholly inadequate to effectively carry on the work of the church and the remaining members have voluntarily requested that it be discontinued as an active church, and, WHEREAS, they have requested that the church property be kept for funerals, and special observations during the year.

THEREFORE BE IT RESOLVED, That the Memphis Annual Conference, in session at Lambuth College, June 3-6, 1958, approve the discontinuance of the Mt. Zion Methodist Church on the Sardis-Milledgeville Charge as an active Church; that the property be placed under control of the Quarterly Conference of the Sardis-Milledgeville Charge, that the duly elected trustees be allowed to open the church only for funerals and special observances during the year and the successors to the present trustees be elected by the Quarterly Conference of the Sardis-Milledgeville Charge." SMITH'S CHAPEL METHODIST CHURCH—The following resolution was adopted.

"WHEREAS, The Smith's Chapel Methodist Church on the Lexington Larger Parish is without resident members, I, therefore move that the Memphis Annual Conference, in session at Lambuth College, June 3-6, 1958, approve the discontinuance of Smith's Chapel Methodist Church and that the duly elected Trustees of the Lexington Larger Parish be authorized to dispose of the property, proceeds to be given to Oak Grove Methodist Church to which the membership of the remaining members shall be moved." WHEREAS, The Pond Creek Church of the Alamo Ct. has been sold for \$3,500.00 as directed by the Annual Conference of 1956, and the proceeds have been invested in Bonds as directed by a resolution passed last year.

WHEREAS, The Resolution stated, quote "If Gadsden Church and Center Church, both of the Alamo Ct. should merge and construct a new church jointly, the Bonds would be sold and the proceeds be used in the construction of said Church."

WHEREAS, Gadsden Church and Center Church do not wish to merge, but Gadsden church wants to remodel and build Sunday School rooms, and Center Church wants to build a new Church. And since Cross Roads Church on the Alamo Ct. has been damaged by fire, at an estimated loss of \$1,000.00

This Church has only 6 members who can be found. The man who had carried it for several years died this year. What members can be found will be transferred to other churches. The property has no Board of Trustees. Therefore we request that the Conference Trustees dispose of the church property, according to Paragraph

that the Conference Trustees dispose of the church property, according to Paragraph 188, the 1952 Discipline.

2. Spence Church, carried as a church on the Holladay Circuit, showing a total 21 members, voluntarily requested abandonment at the beginning of the year due to inability to carry out the work of the church and maintain a budget adequate for any kind of financial program. There is no church property. Meetings have been in a school house. The members who can be found are being transferred to Holladay and Yellow Springs Churches on the same Charge.

3. Pisgah Church on the Hollow Rock Circuit has not been supplied with a pastor for the past two years. It is wholly inadequate for the present and there is no hope for the future. It is within a few miles of Hollow Rock and the members who can be found either live in Hollow Rock or could attend the services there. The church property is in a bad state of repair and could not be used for services. The Trustees of the Circuit should have control of the property. If they fail to handle it properly, the Conference Trustees should make the proper disposition of this property.

4. Sharon Church, carried in 1955 Journal a church on the North Lexington Circuit, and the past year an inactive church on the Lexington Larger Parish, has no future and the church leaders have requested abandonment. The members are being transferred to other Methodist Churches. We recommend that the Conference Trustees dispose of said property.
