THEREFORE, be it resolved that the Memphis Annual Conference in the June, 1999, Session, recognize the faithful ministry of the Lick Creek United Methodist congregation; and declare the church discontinued;

BE IT FURTHER RESOLVED, that all property, the land, and the Lick Creek United Methodist Church building be deeded to the Lick Creek Cemetery Association to be used to ensure perpetual care of the cemetery, and for upkeep and use of the former Lick Creek United Methodist Church building.

Report #7 Conference Board of Trustees

The Memphis Conference Board of Trustees continues its oversight of the fifteen properties owned by the Memphis Conference: seven district parsonages, two Conference Council on Ministries directors' parsonages, the campus ministry buildings at the University of Memphis, University of Tennessee at Martin, Murray State University, and the parsonage for the director of each.

With a budget of \$142,700 for 1998, after actual payout and certain expenses such as taxes, pest control, and debt retirement, which have to be paid at 100%, the actual money available for the upkeep and furnishings of these properties was \$49,012.

In 1998 we were able to pay back in full the debt on the Brownsville parsonage. We have replaced heating and cooling units in two properties, reroofed a couple, paved a drive, replaced flooring, storm windows, drapes, carpet, and painted. In 1999, due to extensive continuing problems with the Murray State parsonage (ground water drainage, exterior wall insulation, and remodeling needs), we hope to replace this property.

The Trustees are to be commended for their efforts in stewardship of the Conference's money and property. They have performed admirably in maintaining the delicate balance between the needs and comfort of the families who reside in these parsonages, the effects of time and the

elements on the properties, the program needs of the ministries we house, and the Conference budget limitations.

The Memphis Conference Board of Trustees is requesting two things from the Conference pertaining to the parsonage of the Campus Fellowship at Murray State University.

That the Trustees be allowed to sell the existing parsonage.

That the Trustees be allowed to purchase a replacement parsonage.

More specifically, we request an advance from the Conference reserve fund which would be sufficient to purchase a new parsonage for the U.M. Campus Fellowship at Murray State University:

We project the total cost of the new parsonage to be \$120,000. We would expect to receive \$60,000 from the sale of the present parsonage. This leaves a net of \$60,000 to be repaid to reserves over a period of approximately five years. This \$60,000 would be paid from an existing line item for debt retirement in the Trustee budget. This would not increase the budget.

- Whereas, the membership of the Murry's Chapel United Methodist Church, in a duly called Church Conference, Sunday, April 19,. 1998, following the 6:00 p.m. worship, and presided over by the District Superintendent, Rev. Ken Burnette, voted to approve the merger 14 for, 2 against, and 2 abstaining, and,
- Whereas, both congregations have approved a proposal that the Boling Memorial United Methodist Church building and land be placed under the supervision of a committee composed of the current trustees for both the merging Boling Memorial United Methodist Church and the Murry's Chapel United Methodist Church, and used for outreach ministries for persons in need, and,
- Whereas, the Bishop and the Cabinet of the Memphis Annual Conference, after duly considering said proposal, have unanimously approved the proposal for merger, and,
- Therefore be it resolved, that the Memphis Annual Conference meeting in Jackson, Tennessee, June 7-10, 1998, approve said merger between these two congregations in conformity to the provisions of THE BOOK of DISCIPLINE, effective retroactive to June 1, 1998.

- Whereas, the remaining members are actively involved in the Good Hope Cemetery Association to offer perpetual care for the cemetery;
- Therefore, be it resolved, that the Memphis Annual Conference in the June 1998 session, recognize the faithful ministry of the Good Hope congregation; and,
- Be it further resolved, that members be encouraged to place their membership in The First United Methodist Church of Dyer, or another church of their choice, and,
- Be it further resolved, that the balance in the Good Hope United Methodist Church checking account be transferred to the Dyer First United Methodist Church operating budget, and,
- Be it further resolved, that all property, including a small certificate of deposit for cemetery and building upkeep, the land and the Good Hope United Methodist Church building be deeded to Good Hope Cemetery Association to be used as the Cemetery Association decides best to insure perpetual care of the cemetery, and upkeep and use of the Good Hope Church building, and,
- Be it further resolved, that the last elected trustees of Good Hope United Methodist Church be authorized to handle the disposition of the property.

Discontinuance of St. Mark UMC

(From the Memphis Conference Cabinet, Paducah District Superintendent)

- Whereas, St. Mark United Methodist Church in the Paducah District has had a long and fruitful mission in the city of Paducah, Kentucky; and
- Whereas, over recent years the congregation of St. Mark Church has declined to the point that in both numbers and financial ability they are no longer able to carry out the mission and ministry of the church in the neighborhood where they are located; and
- Whereas, the congregation in consultation with the District Superintendent, sorrowfully concedes that the church is no longer able to carry on, and
- Whereas, the District Superintendent has consulted with the District Building and Location Committee, and
- Whereas, the District Superintendent has met and discussed the situation with the District Revitalization and New Church Development Committee;
- Therefore, be it resolved, that all property, furniture and fixtures of St. Mark Church be sold by the Conference Trustees, with all monies from said sale remitted to the Paducah District Revitalization and New Church Development Committee, with first priority funding to be given to new ministries in the St. Mark neighborhood and in the surrounding areas of inner-city Paducah, and
- Be it further resolved, that the St. Mark parsonage and its property be passed to the trusteeship of the Paducah District Revitalization and New Church Development Committee for continued use in the mission and ministry of urban Paducah, and
- Be it further resolved, that the membership of St. Mark Church be encouraged to unite with other neighboring United Methodist Churches and that the membership record books be lodged at St. Luke Aldersgate Church for a reasonable time to allow this to happen. All remaining members will then be added to the St. Luke Aldersgate congregation.

REPORT #9

Conference Board of Trustees

The Memphis Conference Board of Trustees has oversight of the fifteen properties owned by the Memphis Conference. These properties include: seven district parsonages, two Conference Council

on Ministries staff parsonages, the campus ministry buildings at the University of Memphis, University of Tennessee at Martin, and Murray State University and the parsonage for the director of each.

Our share of the Conference Budget for 1997 was \$142,400. Our churches paid 83% of that figure which meant \$118,557 was actually available for the care and maintenance of these fifteen properties. Certain expenses such as taxes, pest control, and debt retirement have to be paid at 100%. Again, our total for maintenance was reduced-this time to approximately \$63,613. We do not want to allow our properties to fall below market standards and depreciate in value. The Trustees have a difficult job but each has shown faithful commitment to the task.

For the most part, our-your-properties are in pretty good shape, though we found a few situations that warranted attention beyond the routine maintenance and repair. We painted, repaired, carpeted, and hung draperies. We replaced several appliances and some furnishings, rebuilt two heating and cooling systems, did some landscaping, repaired roofs, replaced windows and took other steps to update these facilities to keep up with current market standards.

AND BE IT FURTHER RESOLVED that the Trustees of the Memphis Annual Conference be authorized to sell the building and land of the Richwood United Methodist Church:

AND BE IT FURTHER RESOLVED that proceeds from the said sale, less costs related to the transaction, be given to the Dyersburg District Church Extension Society.

REPORT # 3 CONFERENCE BOARD OF TRUSTEES

The Memphis Conference Board of Trustees has oversight of the fifteen properties owned by the Memphis Conference. These properties include: seven district parsonages, two Conference Council on Ministries staff parsonages, the campus ministry buildings at the University of Memphis, University of Tennessee at Martin, and Murray State University and the parsonage for the director of each.

Our share of the Conference Budget for 1996 was \$142,400. Our churches paid 79% of that figure which meant an actual \$112,870 was available for the care and maintenance of these fifteen properties. Certain expenses such as taxes, pest control, and debt retirement have to be paid at 100%. Again, our total for maintenance was reduced—this time to approximately \$46,680. We do not want to allow our properties to fall below market standards and depreciate in value. The Trustees have a difficult job but each has shown faithful commitment to the task.

With the beginning of a new quadrennium we began the '96-'97 year with many new persons who were unfamiliar with most if not all of the conference properties under our oversight. To familiarize ourselves with the properties, we took a thorough on site tour of the properties. This enabled each member of the Board to have a first hand knowledge of the needs of each property; and to meet the residents of these properties and hear their personal concerns. For the most part our, your properties are in pretty good shape, though we found a few situations that warranted attention beyond routine maintenance and repair. To that end, in 1996, we painted, repaired, carpeted, and hung draperies. We replaced a freezer, a refrigerator, a couple of furnaces, an air conditioner, some furniture, remodeled a kitchen and added a bath to keep the pace of current market standards. Also, we paid a little extra on the Brownsville District parsonage debt retirement, to boot. You have given the Trustees a sizeable task, one that each member of the Board seeks to fulfill responsibly.

A personal note of thanks to James Finger who made this first year, for me as chairperson, go more smoothly than it might have otherwise.

RESOLUTION # 1 GEORGIAN HILLS UNITED METHODIST CHURCH Whereas, the membership of Georgian Hills United Methodist Church, located in the Memphis-Asbury District of the Memphis Annual Conference, has declined steadily in recent years; and WHEREAS, the numbers of childrn, youth, and young adult members has also declined; and WHEREAS, the basic maintenance costs for the facility and for administrative needs leave few resources for program ministries and for missional commitments; and WHEREAS, the church building is anticipated to require additional maintenance as time goes on; and WHEREAS, the present membership recognizes the difficulty of sustaining a viable ministry in a changing community, and to simply 'maintain' the church as it is for the current congregation falls short of the goals and purpose for ministry and mission that Georgian Hills has held over the years; THEREFORE BE IT RESOLVED, that the 1996 session of the Memphis Annual Conference affirm the faithful service of Georgian Hills United Methodist Church during its 36 years and approve the action of the Church Conference on May 7, 1996, and declare the church discontinued. (See related resolution below on sale and oversight of property). Conference Action: Passed GEORGIAN HILLS UMC PLANS FOR 1996 AND BEYOND Georgian Hills seeks to sell the property, with the understanding that it may take 18 months to a few years for such sale to occus. As of Annual Conference 1996, United Methodist Resources for Ministry assumes responsibility over the property until it is sold. This includes: * Allowing the facility to be used within the parameters of community ministry and resources available for such usage. * Working with the designated real estate agent for showings, etc. * Paying all expenses until building/property is sold (See C). * Having final determination of what programs/ministries can be placed in the facility as it is on the market; though a Senior Citizens ministry through Schoolfield UMC may be an understood part of ministry in the facility. The costs of maintaining the facility will be covered by present and/or future assets of Georgian Hills Church: * When the Georgian Hills parsonage is sold, the net profits, exclusive of the amount for a van for the senior citizens ministry at Schoolfield UMC, will be given to UMRM as escrow funds for maintenance costs. * Any costs that UMRM has to bear beyond the available escrow funds will be reimbursed UMRM when the building/property sells. The Georgian Hills congregation, in consultation with the District Superintendent, hereby requests/is granted the assurance that 60% of the net profits from the sale of the church building will be granted to Schoolfield United Methodist Church through United Methodist Resources for Ministry and that 40% of the net profits will be granted to United Methodist Resources for Ministry, especially with the growing financial responsibility of the Frayser area ministries. (Again, the net

profits encompasses that amount available after all costs assumed by United Methodist Resources for Ministry while the church facility was on the market have

been reimbursed.)

RESOLUTION #3 BOOSE MEMORIAL UNITED METHODIST CHURCH

WHEREAS, the active membership of the Boose Memorial United Methodist Church in Dyersburg had declined to ten persons, and WHEREAS, this active membership could no longer carry on the program of

missional outreach appropriate for an organized congregation of The United Methodist Church, and

WHEREAS, in a called Church Conference, October 29, 1995, the remaining active membership voted unanimously (with one abstention) to cease worship effective December 31, 1995, and

WHEREAS, on December 31, 1995, a final service of celebration of past ministry, and of Leavetaking and Disbanding, concluded the use of the property for United Methodist purposes, and

WHEREAS, the Dyersburg District Superintendent on the authorization of the last elected trustees has leased the property to an organizing independent African-American Congregation known as the New Birth Church, and

WHEREAS, the said organizing congregation has made a proposal to purchase the property,

THEREFORE, BE IT RESOLVED that the Memphis Annual Conference, meeting June 2-5, 1996, at Christ United Methodist Church, in Memphis, Tennessee, formally discontinue the Boose Memorial United Methodist Church;

AND BE IT FURTHER RESOLVED that the Memphis Annual Conference be authorized to sell the property to said New Birth Church for the sum of \$30,000 or, should that sale not be consummated, sell the property to such party and for such sum as approved by the said Trustees;

AND BE IT FURTHER RESOLVED that the proceeds from the said sale, less costs related to the transaction, be given to the Dyersburg District Church Extension Fund, to be used for its purposes, including, but not restricted to, emerging Hispanic ministries.

RESOLUTION # 2 BETHLEHEM UNITED METHODIST CHURCH

WHEREAS, the Bethlehem United Methodist Church, located in South Fayette County, TN, in the Memphis-McKendree District, has declined to only five active members, and

WHEREAS, in a special called CHURCH Conference held on May 11, 1996, the members present voted unanimously to cease holding worship services and requested the discontinuance of Bethlehem Church as a United Methodist congregation, and

WHEREAS, a cemetery is located on the adjoining property, and

WHEREAS, the Bethlehem Cemetery Association wishes to keep the property for use as a funeral chapel; THEREFORE BE IT RESOLVED THAT, the Memphis Annual Conference, meeting in session June 2-5, 1996, in Memphis, Tennessee, authorizes the Conference Trustees to sell the church property to the Bethlehem Cemetery Association for \$1.00, plus all other costs related to said transaction.

RESOLUTION # 4 OAKLAND UNITED METHODIST CHURCH

Whereas, the membership of Oakland United Methodist Church of the Saltillo Circuit, located in the Jackson District of the Memphis Conference, has declined in membership until it membership is two; and

WHEREAS, the congregation ceased to worship together as of December 24, 1995; and

WHEREAS, the District Superintendent has determined that future growth is not a possibility for the church because TVA has purchased most of the property in Hooker's Bend Community; and

THEREFORE BE IT RESOLVED, that the 1996 Memphis Annual Conference meeting June 2-5, 1996, affirm the faithful witness and service of the Oakland United Methodist Church and declare the church discontinued;

BE IT FURTHER RESOLVED, that the Oakland United Methodist Church property be deeded to the "Oakland Methodist Cemetery Association", which shall maintain the property for a perpetual cemetery, with rights to sell, lease, or otherwise dispose of the property.

THE MEMPHIS CONFERENCE CABINET (From the Jackson District Superintendent)

REPORT # 4 CONFERENCE BOARD OF TRUSTEES

The Memphis Annual Conference owns 15 buildings. The Conference owns parsonages for the seven district superintendents, the CCOM director, one CCOM ministry associate, and three campus ministers. We also own campus ministry buildings at the University of Memphis, U.T. Martin, and Murray State.

As you all know, it is impossible to predict exactly when repairs will be needed to our parsonages and other buildings. The Trustees started 1995 with a surplus of \$9,739. This was money left over from the sale of the Lexington parsonage several years ago. The Trustees' total budgeted receipts for 1995 were \$139,600. The churches paid 82.4% or \$115,037 of that budget. After considering that certain expenses have to be paid at 100%, i.e., taxes, insurance, note payments, etc., the Trustees had approximately \$55,000 to maintain the 15 properties. We replaced air conditioning equipment in all three campus ministry buildings at a cost of \$24,400. We, therefore, had to defer a good number of projects. Hopefully in 1996 some of those deferred projects can be done.

Should the Conference consider a different method of funding the property upkeep in the future? I don't know. It probably needs to be considered.

Please allow me a personal word. This is my last year on the Trustees. To have served as Chairman of this Board for the last few years has been a pleasure and a privilege. At most meetings we have almost 100% attendance. All the Trustees do their jobs. I thank them for their support and friendship.

The Memphis Annual Conference was the benefactor of a 154.25 acre farm located in Tipton County. The Trustees handled the sale of the farm which sold for \$208,000.00. After expenses, back taxes, etc., the Conference net amount was \$193,687.96. These funds as directed by Mrs. Alice Gray, donor, were disbursed to the Memphis Conference Board of Pensions.

The 1994 budget request appears in the CFA report. As Conference Trustees, we have tried to be good stewards of your money and worthy of the trust you have placed in us.
